Tax Efficient Giving

If you are a UK taxpayer, please complete the *Gift Aid* declaration on the donation form, which will allow Darwin College to reclaim the tax on your donation. This allows the College currently to claim a further 25p from HM Revenue and Customs for every £1 that you give. **For example:** If you donate £25 a month over 4 years this would amount to £1,500 with gift aid.

If you are a higher-rate taxpayer, you may also then claim further personal tax relief on any *Gift Aid* donations you make when completing your self-assessment tax return. **For example:** If you make a single donation of £1000 to Darwin College after we reclaim the tax it is worth £1,250. The benefit to a higher rate taxpayer is £250. So, a £1,250 gift has cost the donor £750.00.

Gifts of shares, securities and property

Gifts of shares, securities and property by UK taxpayers attract full tax relief from Capital Gains Tax and allow the donor to claim income tax relief on the full value of the gift at the time of transfer. Please contact the Development Director if you are interested in donating this way, he will be pleased to advise you.

Payroll giving

This is a simple and tax efficient way to donate directly from your monthly salary. You decide how much you would like to give on a monthly basis. The deductions are made before you pay tax and therefore you get tax relief on your donation. If you are a basic rate taxpayer and authorise a monthly donation of £10 then the net cost to you is only £7.80. Please speak to your employer for more information.

Leaving a legacy to the College

Please consider leaving a legacy to the college in your Will. This has many benefits, it will reduce the inheritance tax that has to be paid on your estate and there's also an additional incentive for people to leave at least 10% of their net estate to charity, as they will pay a reduced rate of inheritance tax on the remainder of the estate. The rate of inheritance tax for amounts over £325,000 has been cut from 40% to 36% for estates that leave 10% or more to charity. Please contact the Development Office to discuss further.

Donating from outside the UK

Alumni resident in the USA

If you are living in the USA and would like to make a tax efficient donation to Darwin College, then you can do so through *Cambridge in America* (CAM). CAM is a registered US501(c)3 charity. Gifts can be made using checks, Visa, MasterCard and American Express. Gifts of securities, gifts in kind, and planned gifts can also be accepted. If you are interested in leaving a legacy to The College, this can also be discussed with CAM. To give by check, download a donation form from their website www.cantab.org. If you are subject to tax in both the UK and the US, you now have the opportunity to give to Cambridge in America (UK) Ltd, a registered charity in the UK, and thereby be simultaneously eligible for tax benefits in both countries. www.cantab.org/supporting-cambridge/cam-uk

Alumni resident in Canada

Canadian taxpayers can give to the College by sending donations directly to the College Alumni Office or via our online facility. Cambridge Colleges are currently unable to provide a Canadian approved tax receipt, but are hopeful that this will change in the near future.
